RE: GCCF IMPROPER CONTACTS

Dear Mr. Feinberg:

It has come to my attention that representatives of GCCF are routinely contacting claimants who are represented by legal counsel. Those contacts include claimants who are represented by our law firm. As you know, these contacts violate Section 3 of the protocol and will not be tolerated.

So there will be no misunderstanding, each of our clients who were contacted, numbering over 200, had previously been assigned claimant identification numbers, which were in your system. Additionally, each of our clients had already filed the required claims with supporting information with GCCF. At the time of filing, our clients were assigned a claim identification number. GCCF had on file the names of each lawyer from our firm handling claims for a client. This would have been known to GCCF at the times of the improper contacts.


Nevertheless, improper contacts were made by GCCF and our clients were told to fill out new claim forms and send them in to GCCF. It appears that many of our clients now have at least two claim identification numbers, which is very confusing to say the least.

We consider these client contacts to be an interference with our contractual relationship with clients. You are hereby put on notice to make no further contact with any client represented by our law firm. All contacts by GCCF must be through the firm. We have attempted to cooperate fully with you and GCCF and were shocked at this conduct. In fact, lawyers from our firm have met with you personally and discussed the claims process with you. The desire of our firm was to file emergency claims on behalf of clients who wanted to first deal with BP's claims process and then with GCCF once that claims process took over from BP. Our goal is to represent our clients and obtain for them all that they legally are entitled to. Our experience with BP and now with GCCF has not been very good. Hopefully, you will see that the claims process is handled properly and in a fair manner.

I am sure you realize the serious nature of this request. It appears that GCCF is not only attempting to interfere with a contractual relationship, but is also wasting a great deal of time, effort, and money in the process. If you have any questions concerning the above, contact me immediately.
